### Investment objective and strategy

The investment seeks capital appreciation. It invests at least 80% of assets in securities (primarily in common stocks) of companies with small market capitalizations where the manager believes securities are undervalued in the marketplace in relation to factors such as assets, sales, earnings, growth potential, or cash flow, in relation to securities of other companies in the same industry. It invests in both domestic and foreign issuers.

# **Category - Small Value**

Small-value portfolios invest in small U.S. companies with valuations and growth rates below other small-cap peers. Stocks in the bottom 10% of the capitalization of the U.S. equity market are defined as small-cap. Value is defined based on low valuations (low price ratios and high dividend yields) and slow growth (low growth rates for earnings, sales, book value, and cash flow).


